CALL TO ORDER

President Cheng called the meeting to order at 6:00 p.m. She led those present in the Pledge of Allegiance.

REPORTING OUT FROM CLOSED SESSION

President Cheng reported that no action was taken in closed session.

AUDIT AND FINANCE REPORT

Trustee Betsy Bechtel reported that she and Trustee Barram serve on the Audit and Finance Committee along with four community members. The committee met on Thursday, September 8, 2011. The committee approved the reports on Measures E and C projects. The committee also reviewed management's response to the performance audit by external auditors Vavrinek Trine and Day (VTD). VTD staff attended the meeting and provided an audit update. They will submit their final report to the committee in December, and it will be presented to the Board in January.

The committee had an in-depth discussion of the 2011-12 budget. Questions were raised whether the district has set aside sufficient reserves, how it is addressing the structural imbalance, and how the district is trying to increase revenues. Vice Chancellor of Business Services Kevin McElroy and Budget Director Bernata Slater answered all of the committee's questions. Trustee Barram felt the committee was very comfortable with how the district is being managed and voted unanimously to recommend board approval of the budget.

The committee discussed the performance audit of the district's procurement cards. One of the items addressed was the recommendations made, but not properly implemented, in the previous procurement card audit. Trustee Bechtel stressed the risks of not implementing or addressing those recommendations. District staff will report back to the Audit and Finance Committee in December.

Foothill President Judy Miner recognized four Foothill instructors. Academic Senate Vice President Carolyn Holcroft has been appointed to the statewide committee on curriculum for the Academic Senate. Academic Senate President Dolores Davison has been named to four committees: two Foothill technology task forces, the distance education ad hoc committee, and the occupational education committee. President Miner also reported that astronomy instructor Andrew Fraknoi is part of the Bay Area Science Festival organization. Over 100 events related to science in the Bay Area are scheduled between October 29 and November 6. President Miner said trustees can look forward to receiving additional information about a "star party" on November 5 hosted by Foothill College. David Packard of the Packard Humanities Institute has reached out to music instructor Bruce Tambling to record the San Jose Opera's performances during its opera season. Instructor Tambling and his students have recorded the first opera. The institute has earmarked \$3 million for the project. President Miner said to be called upon to work on a project of this caliber is a great honor and opportunity.

Chancellor Linda Thor reported that she and Vice Chancellor McElroy met with the chairs of the accreditation teams last week. Chancellor briefly outlined the accreditation schedule. Trustees' attendance at the accreditation receptions and exit reports is encouraged, but are optional. However, she did request that board members be available on Tuesday, October 25, to meet individually with the team members. Additional information will be forthcoming.

<u>Board</u>

Trustee Joan Barram, Trustee Laura Casas Frier, and Chancellor Thor attended the Cupertino Fall Festival at which the Foothill-De Anza Foundation and the California History Center had a booth and the Euphrat Museum was conducting hands-on art projects for children. Trustee Barram said the event is a reminder of the diversity of the communities served by the district.

Trustee Laura Casas Frier said that many elected officials attended the opening ceremony and ribbon cutting. The representation by Fremont Union High School District and Cupertino Union School District gave the festival a strong community feeling. President Cheng added that she attended the festival that afternoon.

Authorization to Negotiate and Approve Change Orders in Excess of \$50,000 for De Anza College Project #274, Combined Site Improvements, Phase I

Executive Director of Facilities, Operations, and Construction Management Charles Allen explained that this item addresses the need for change orders in five different areas. The project addresses:

- improvement of ADA access from public transportation drop off points in parking lots
- lighting upgrades
- safety-related pedestrian improvements
- pedestrian pathway improvements between the parking lots and the campus
- elimination of flooding problems in the S-Quad
- improvements, durability, appearance, and maintainability of the thoroughfares into the campus from various points around the campus

Executive Director Allen anticipates that the work will be almost totally complete by the first day of classes, with the exception of the area near the Sunken Garden. However, clearly marked pathways will be indicated for pedestrians.

Trustee Bechtel expressed concern that now, as in the past, similar exceptions have been authorized between board meetings. She does not want the exceptions to become routine and for staff to assume that board authorization will be granted. Executive Allen responded that this is a unique situation and he does not expect this type of request to become routine.

Executive Director Allen assured Trustee Casas Frier that the expense is included in the project budget. Trustee Casas Frier asked if the district could be reimbursed for the extra costs by the contractor. Executive Director Allen responded that in this case, the costs are mostly driven by the limited timeframe in which the work needs to be completed rather than oversights by the contractor. The very tight timeframe could not have been anticipated by the contractor.
