PUBLIC SESSION

Before calling the meeting to order President Barram remembered Carmen Redmond, Director of Purchasing Services, who unexpectedly passed away on September 11. President Barram extended condolences to Carmen's staff and all who worked with her. Carmen will be remembered fondly by everyone who knew and worked with her. Adjournment of the meeting will be in remembrance of Carmen. President Barram thanked Gina Bailey who has agreed to step in as Acting Director of Purchasing Services until a permanent replacement is in place.

CALL TO ORDER

President Barram called the meeting to order at 6:06 p.m. She led those present in the Pledge of Allegiance.

President Barram reported that in closed session the board discussed and took action to affirm and ratify the dismissal of an employee in a classified Administrative Assistant I position.

HEARINGS: ITEMS NOT ON THE AGENDA

Acting Chancellor Judy Miner reported that Chancellor Linda Thor is in Washington, D.C. attending an invitation only symposium on "Innovation to Drive Productivity in Postsecondary Education" sponsored by the US Department of Education and the White House Office of Science and Technology Policy. Later in the week Chancellor Thor will travel to Kansas City to attend the League for Innovation board meeting where she will extend a formal invitation to attend the Spring 2013 board meeting hosted by Foothill-De Anza. Acting Chancellor Miner then reported that Foothill has received a \$900,000 grant from NSF for a comprehensive student support service grant submitted by Ion Georgiou and Lori Silverman. Their goal is to increase Foothill's STEM major graduates by 95% (about 482 students) over the next 2 years. Lastly, Acting Chancellor Miner led a standing ovation to acknowledge Donna Toyohara's retirement and last board meeting as Executive Assistant to the Chancellor. She announced that Chancellor Thor would offer official recognition for Ms. Toyohara's service at the Board meeting on November 5.

<u>Acting De Anza President Letha Jeanpierre</u> reported that De Anza's headcount is at 23,516, and although FTES is down 1%, students have until Saturday to add classes.

During opening week welcome tables were set up and staffed by volunteers. "Ask Me" stickers were distributed to all faculty and staff to identify them as sources of information. Tours of the Media and Learning Center were given, and training for faculty and staff was provided by Donna Jones-Dulin, Pippa Gibson, Marty Kahn and Ed Breault. Acting President Jeanpierre noted that the MLC was recognized by the Silicon Valley/San Jose Business Journal as a finalist in the "Best Green Public Project in 2012".

Opening week also focused on the upcoming elections. Literature was distributed on how to engage students in the classroom, descriptions of key propositions, and a list of upcoming events. Additional information can be found at www.deanza.edu/vote.

Acting President Jeanpierre announced that on October 3 from 10:30 - 11:30 a.m. California Secretary of State Debra Bowen will speak about the November election and the importance of voting and other civic engagement. The event will be held in Conf. Rooms A/B in the campus center.

<u>Foothill Classified Senate President Erin Ortiz</u> thanked all those who assisted with the success of the district and college opening days and opening week. She reported that the Classified Senate had a successful leadership retreat. Dean of Students Pat Hyland presented as well as Dr. Helena Ting from Palo Alto University. She extended an invitation to all to attend the next Classified Senate meeting on October 11. Lastly, President Ortiz acknowledged and thanked Student Trustee Zavala and the ASFC for funding the student orientation for over 500 students. Breakfast and lunch were provided, workshops were given, and each participant was given a backpack filled with helpful information.

<u>De Anza Faculty Senate President Karen Chow</u> acknowledged a successful opening day and thanked President Murphy, Cynthia Kaufman, and Nicky Gonzalez Yuen for their workshop presentation on Political Mobilization and everyone who participated in the set up, organization, and staffing of strategically placed "Help" desks around campus during opening week. President Chow acknowledged Board President Barram for being on campus on opening day; Student Trustee Vince Mendoza for his efforts in coordinating student volunteers to staff the Help desks; and the Marketing and Communications office for designing the "Ask Me" buttons and detailed campus maps that were distributed to students.

<u>Foothill Academic Senate President Dolores Davison</u> thanked Executive Director Allen and everyone involved in the central campus project for all the work accomplished during the summer in order to be ready for the opening of fall quarter. With very few exceptions, all walkways were accessible, and students commented on how great the campus looks and the amount of work that has been completed.

<u>De Anza Student Trustee Vincent Mendoza c</u>ommented that during opening week hundreds of voters were registered and voter information pamphlets were distributed. He was also pleasantly surprised at the number of faculty who took time out of their day to staff the Help desks.

<u>Foothill Student Trustee Antonia Zavala</u> reminded everyone of Political Awareness Day on October 10 and announced that Assemblyman Rich Gordon will be speaking in the Hearthside Lounge on Tuesday, October 2 at noon.

<u>Trustee Laura Casas Frier</u> thanked the League of Women Voters for organizing the candidate open forum. She acknowledged that both student trustees attended the training on registering voters. On the state level, Trustee Casas Frier expressed concern that polls indicate a decline in the Latino community's support of Prop 30.

<u>Trustee Betsy Bechtel</u> commended all who participated in the District Opening Day program and complimented Chancellor Thor and President Barram on their speeches.

<u>Trustee Pearl Cheng</u> thanked President Barram for participating in United Way's forum on education propositions where speakers addressed the impacts of Propositions 30 and 38.

<u>President Joan Barram</u> said that on district opening day the focus on new faculty, staff, and past students contributed to a sense of warm, effective community team building. She also complimented Foothill for a very inspirational opening day program. President Barram said she enjoyed the atmosphere of the first day of classes at De Anza and acknowledged the visibility of help desk volunteers throughout the campus.

AUDIT AND FINANCE REPORT

Trustee Bechtel reported on the September 13, 2012, Audit and Finance meeting. The committee reviewed the Measures E and C progress reports and had an extensive discussion regarding the actuarial report and whether the district is setting aside sufficient funds for medical benefits and its unfunded liability. An auditor from VTD, the district's external auditor, was present to review the district's auditing program and progress so far.
