There were no students or members of the public who wished to address the Board on items not on the agenda.

De Anza President Murphy thanked the trustees who attended the opening events for the Visual and Performing Arts Center and the Euphrat Museum of Art. Foothill President Judy Miner acknowledged the work of Middlefield Campus Dean Denise Swett and Outreach Specialist Alexandra Duran for organizing a college prep family program event at the request of the Boys and Girls Club of the Peninsula. She expressed appreciation to Instructor Laureen Balducci for organizing the second Community College Careers Consortium conference for regions 3 and 4 at Foothill. Lastly, she announced that the college would host a national Focus the Nation sustainability summit for educators, students and civic leaders on April 18.

Chancellor Martha Kanter reported that the Community College Consortium for Open Educational Resources met earlier in the day, and 89 colleges from the United States and Canada have now joined the Consortium. She announced that appointments with legislators have been scheduled for students during the March 16 rally in Sacramento. She shared a letter from Congressman Mike Honda congratulating De Anza on the opening of the Visual and Performing Arts Center. She also said that she had been invited to speak at an upcoming meeting of the Community College EOPS/CARE Consortium.

Faculty Association (FA) President Rich Hansen read a statement that, while FA and the District were able to reach agreement regarding an increase to part-time faculty load, as provided for by recent legislation, FA expressed disappointment that the District had not agreed to using

reemployment preference to determine the method by which additional assignments were made, and which FA believed to be inherent in the legislative intent.

TRANSFER OR REASSIGNMENT OF EMPLOYEES AND SUSPENSION OF POSITIONS DUE TO LACK OF FUNDING

Responding to a question from Trustee Swenson, Foothill President Miner clarified that the position of Dean of Computer Technology and Information Systems would be fully funded by a grant instead of by Fund 14, and the current dean, Tim Woods, would continue in the position under the changed funding arrangement. She explained that the position would assume additional duties related to the grant, and added that the proposed change was not related to enrollment patterns in the division, which have been increasing lately after a sharp decline several years ago. Addressing the proposed suspension of two faculty positions, she acknowledged the dedication of the two faculty members in the affected positions and said it was a difficult decision.
