Agenda Items:

- 1. Text Message Replies.
 - All text messages come from same phone number; when student opts out from receiving messages from one department (like Financial Aid), will they also opt out from receiving messages from other departments?
 - Core members decided students must opt out from receiving messages from each department, opting out from one department will not stop messages from other departments from going out.
 - Will need to setup three opt out messages; Financial Aid, Student and Counseling.
 - Need a place in student's record to record the texting opt out; keep from being included in next list.
 - Test message sent out to Financial Aid students was successful.
- 2. Course Studio Support.
 - Suggested support procedure, DA Julie Ceballos, FH (TBD) to support the first line user request, if they have technical support issues or problems, contact Call Center and Joe Lampo's group will support it afterwards.

- 3. Faculty Leave Reporting March 2013, Spring quarter.
 - Go Live with one division February 8, 2013 Foothill PE.
 - Go Live with another division end of February, early March 2013 De Anza Business.
- 4. Oracle 11g Conversion.
 - Upgrade HP-UX to version 11.31 January 18, 2013.
 - Build Oracle 11g home directory January 22, 2013, pointing at PRODN.
 - Certify February 1st or 8th.
 - Install Financial Aid 8.16 and CalB-FA 8 together in February.
- 5. Behind on Banner Upgrades.
 - Need to update to current CalB; begin researching.
- 6. IA Plus system retires June 30, 2013.
 - All data moved into Oracle or Banner by June 30, 2013.
 - Have plan to migrate historical data.
- 7. FSA Atlas.

 - Colleges currently using work around.
 - Looking into iApp developed by Santa Monica College.
