Foundation Weekly Meeting Minutes-Revised May 3, 2011, 9:00am-10:00am

David Gilmore from SGHE is onsite this week for technical support.

- 1. Interface with Payroll:
 - Will go live with payroll deduction July 1, 2011.
 - Pledges will have to be entered ahead of time into Advancement.
- 2. Pledge Acknowledgement Letters:
 - ARGOS consultant working on; has specs.

Process to Go Live:

- 1. Donorworks is now frozen.
 - No more gifts are being entered.
- 2. Conversion clone to pre-production (PRODN).
 - Begin Donorwork conversion May 3, 2011.
 - o Process will take 1 ½ 2 days.
 - o 17,800 records to convert; 9,000 new records.
 - No major issues with rule and validation tables confirmed by David Gilmore & Robin.
 - Will clone production to TEST8; verify data.
 - Dual updates mode will begin once cloned.
 - o Make changes in TEST8 first, verify correct, then make changes in PROD (production).
- 3. Contingency Plan:
 - David Gilmore from SGHE will be onsite the week of May 2, 2011 for technical support.
 - Chien will work on having Noelle Hylton onsite the week of May 2, 2011 for functional support.

Payroll & Finance:

- Comfortable with testing last week.
- Finance needs to make changes to rule and validation tables in production before cloning to TEST8; team is ok with Finance making changes in production.
- Foundation tested all scenarios and processes worked.
- Will manually feed into Finance on demand to make sure process works correctly; will automate later.
 - o Feed will go directly into Foundation account in Finance.
 - o Safe guards are in place for manually feeds so there is no duplication.
 - o Back dating is ok with Finance.
- Issue with gift already posted in Finance (April) but will not be posted in Foundation until May.
 - o Entangled Gifts need to be entered into Banner Advancement because Donorworks has been frozen.
 - o Kathy will need to do a reverse cash receipt for April after gifts are entered in Advancement.
- Payroll deductions are renewed every fiscal year.

- Payroll needs to verify signatures for deductions.
- Need a way to automate signature verification for 250 existing employee deductions, then once every year for renewal.
 - David Gilmore & Noelle Hylton of SGHE will look into.

Take Away Items:

- 1. Team agrees Donorwork conversion can begin May 3, 2011.
- 2. Any changes made to rule and validation tables in TEST8 need to be verified and made in PROD by May 5, 2011 (verified by Foundation, Finance and Payroll).
- 3. Donorworks data dump needs to be verified by ETS by May 5, 2011.
- 4. Clone Thursday night May 5, 2011 from PROD to TEST8.
- 5. Final testing done Friday, May 6, 2011 in TEST8
- 6. Report any issues to Robin and Chien to be resolved.
- 7. No issues; clone again Saturday night May 7, 2011.
- 8. Foundation will be in production May 9, 2011.
- 9. After go live, will do parallel entry to Production and TST 8 for a week to make sure everything is OK. Cloning will be done on a nightly basis from Production to TST8 after go live.
