Standing Agenda Items:

- 1. 11g Conversion Issues.
 - Single sign-on for Mac users into INB does not work; patch works for operating systems 10.6 and newer, will apply patch when older Macs have been upgraded.
 - o Tech services will identify and begin replacement mid-July.
- 2. Summer Registration.
 - 13,700 registered at De Anza.
 - 9,770 registered at Foothill (includes early Summer registration).
- 3. Block online enrollments for students living in 5 states charging licensing fee to out of state school residents take online classes when uploading from CCCApply.
 - Testing in PRODN; need to certify.
 - Having problems with testing; need to create students in CCCApply for testing.
- 4. Installment Plan/Pay to Stay Project.
 - Implement Touchnet installment plan August 22, 2013.
 - o DAD installed/configured.
 - o TouchNet finished Banner connect; testing connectivity.
 - o Working on single sign-on.
 - o Schedule training week of July 11, 2013; remote WebEx.
 - Begin rolling drops September 1st until first day of school.
 - Installment plan fee still in discussion.
 - Implement Pay to Stay policies Winter quarter.
- 5. ID Card/Printing Services Project.
 - Separate printing services from Capture Card/implement new printing services September 3, 2013.
 - o August 9, 2013 cut off GoPrint to students; need to communicate to students.
 - o Printers on order; colleges have finalized printer deployment locations.
 - Printers should arrive after 4th of July holiday.
 - Need to install print driver on computers in all labs.
 - Pilot printing and new ID cards at both colleges in July 22, 2013; will have a second pilot test August 12, 2013.
 - Multicard chosen by ETAC and selection committees.
 - o New equipment, cameras, printers in place by September 1, 2013.
 - o Card production equipment has arrived.
- 6. Open CCCApply convert June 2014; begin early 2014.
 - Contract renewal June 30, 2013; Foothill wants to purchase module for non-credit.
 - International Students offices want to automate application process; currently use paper application and enter info manually.

- o Use Xap until CCCApply version is ready.
- o Demo of Xap module from Grossmont College.
- 7. Need to change enrollment priorities for Fall 2014.
 - Specifications completed; consultant reviewing.
 - Test against Fall quarter data; October 2013.
 - Need to communicate change to students end of this academic year.
- 8. Apply/Unapply Processing time issue nightly batch run taking longer to run.
 - As registration volume increases, process takes longer to run.
 - Still not satisfied with run time; does finish on time.
- 9. Student Success Checklist Summer 2013.
 - Currently testing.
 - Need student IDs for testing; use Counseling 5 for Foothill, Counseling 200 for De Anza.
 - High School students after 1989 began earning college credit; need report to find students with college credit.
- 10. Legacy sunset date June 30, 2013:
 - Data migration done; Currently testing.

11. Census:

- Roster 4.1 June 2013.
 - o Confirmation email to instructors after sending census.
 - o Double click sensor.
 - o Green check mark after electronic signature found in Banner.
 - o Have users test in PRODN before releasing into Production; need faculty to test.
 - o Currently testing; move into Production June 27, 2013.

12. BDMS:

- Student records on microfilm, microfiche, old CDs; need way to access records.
 - Joe Lampo will follow-up.
- Foothill Disabled Students will demo for District Office.
- 13. Counselors would like placement score view added to dashboard; complete when new dashboard is available, Summer 2013.
- 14. Degreeworks:
 - Ed plan already approved missing ticket with Action Line; lead developer at Ellucian working on.
 - o Install 4.1.1 in test instance July 2, 2013 and begin testing.
 - GPA calc tab getting error for term calculator; fix from Action Line did not work; updated ticket.
 - o Fix works for De Anza but not Foothill.
 - When former students return after a lapse in registration, CCCApply will pull in old term (when first registered) and students cannot get into DegreeWorks.
 - Request from De Anza Counseling department to involve counselors with testing future releases before moving into Production.
 - Email list to Stephanie Franco for Summer testing.
- 15. Financial Aid Refunds Issue:
 - Change process automate; labor intensive, may need consultant help.

- 16. Repeatability needs to be removed from all courses (State mandate) effective Fall 2013.
 - 29 families need to be built; 5 built so far for both colleges.
 - o If tested properly, will test results be the same for remaining families?
 - o Foothill equivalencies built in Production, not in test environment.
 - Problem with reading terms; need help from Action Line.
 - o Possible work around use Foothill term code.
 - Need to test work around for both colleges.
 - o Will need to run reports and drop manually.
 - CALB Student 8.7 in Production August 2, 2013.
 - o Will not be able to thoroughly test before moving into Production due to staffing issues.
 - o Will need reports to fix errors.
- 17. Registration Survey Institutional Research request.
 - Force students to answer 2 survey questions when registering in Luminis.
 - In PRODN, ready for testing.
 - o Survey works; will disappear after student fills out and will not re-appear.
 - o Registered students only; will have to link to add/drop screens and registration.
