Act as state Inspector on major fire/life safety construction projects within the District. Prepare correspondence and informal contracts to agencies and vendors for material and labor agreements. Coordinate all hands on repairs related to alarm and sprinkler systems. Perform construction management duties for all construction projects relating to fire/life safety.
