The Framers of the Central Services Classified Senate

Over seven years ago, several of our central services classified staff brought forth upon the Foothill-De Anza Community College District the idea of a new senate group, conceived in liberty, and dedicated to represent and improve communication for the central services classified employees. In 2005/06 the Central Services Classified Senate served as the District's newest constituency group and was the only senate group at that time to solely represent district/central services employees in the entire State Community College System!



In the past, the FHDA Central Services classified employees participated in either the Foothill College Senate or the De Anza College Senate depending on which campus the employee worked. In order to form a more perfect union of likeminded individuals and to address issues that were unique to the departments that serve and support the campuses including ETS, Plant Services, Accounting and Budget, Safety and Security, the Chancellor's Office staff, and the Foundation, the "Framers" of the Central Services Classified Senate set to work in an organized fashion to obtain their freedom and to communicate as an independent group. Gaining administrative support, first from management through our newly formed Employee of the Month Committee, a few good women and men got busy forming and serving on committees to develop and write the bylaws and form the senate groups.

We could not have formed the Central Services Classified Senate without the support of the Central Services Management. From the Directors to the Chancellor, we had support to form the new senate group. Mike Brandy (framer), former Vice Chancellor of Business Services, was our "Benjamin Franklin" who supported our cause, negotiated and found funding for our group and spoke highly of us not just at our District, but across the State at the various conferences and committees that he attended. Without Mike and also Bernata Slater, Budget Director, we would have a senate with empty pockets. The Human Resources area and the support of Jane Enright (framer), former Vice Chancellor of Human Resources was key. Jane allowed her staff to spend time developing the senate bylaws and Kim Chief Elk (framer), former Director of Human Resources, communicated with upper management the need for a central services senate group.

Marilyn Booye (Mega Framer), DSP&S Coordinator, working in Employment Services in the District Office during the "pre-senate" days, is our "Thomas Jefferson," as she authored the senate by-laws, gathered information to help form the new senate and worked diligently chairing several committees that helped to create the senate. Marilyn also coordinated the first election of the senate officers and continued working with the senate once it was established. I truly believe that without Marilyn's hard work, dedication and determination, we would not have a classified senate for central services employees.

The Classified Senate has our Betsy Ross's (American flag creator) as well. Our fantastic and unique logo was designed by two central services employees. Look for the article in this newsletter for details about the creation of the logo. The hands and arms of our logo connected in a "firemans hold," representing the diversity of our members and reflecting the unity and strength of our group, was designed and created by Ray Sarria in Employment Services. The graphic layout of the logo, which includes Ray's artwork, with the circular wording and the pointed emblem was designed and created by Drake Lewis in ETS. Thanks to Ray and Drake and the "Logo Committee" members that reviewed and approved the logo. We hope that the Central Service Classified Senate enjoys our wonderful logo for years to

The CSCS Logo

You probably have noticed the Central Services Classified Senate (CSCS) logo at the head of this newsletter or on our website, and perhaps you may even have wondered how it came to be. This is the story.

The CSCS originated with the first vote for senators and officers that took place in April of 2005. We started to meet each month in June of that year and after a few meetings, the group decided we would need some help to get the word out. For that purpose the CSCS decided to form a Public Relations subcommittee. New senators Gina Bailey, Ray Sarria and I volunteered, and we had our first meeting of the PR group on November 8 of that year.

The subcommittee group came up with several suggestions for promotional materials (like the website and this newsletter) and decided that we needed a logo to use in this effort. Several draft designs came to our first meeting, but none of them caught our imagination. After rejecting a few early versions, the PR group discussed what we wanted the logo to represent, and then in early February of 2006, Ray had an idea.

Ray wanted to create an image that included the idea of the diversity of the CSCS organization, the bargaining units and the students and staff on our campuses. His first thought was of a group of people holding hands. After a few tries, he rejected that idea as too complicated, and began to focus just on their hands. He shaded the individual hands to represent the diversity of our group.

As we started to develop the idea, a specific concern arose. Someone had discovered a similar graphic being used by an insurance company, and a few worries about copyright or trademark infringement were voiced. However after we found their logo online we saw that it only had three hands, and decided to move forward with Ray's idea.

Once the initial drawing was done, I worked to re-create it in Adobe Illustrator to make an image that could be reproduced in both large and small sizes without sacrificing detail. I added the color, wording and an outline to make it useful as an official "seal". It has since been used in many applications, including the Employee of the Month awards, and a large banner used for CSCS events where the logo is about a foot and a half wide. It has become an easily recognizable symbol for our group over the past five years.

I was a CSCS senator for three years, until term limits made it necessary to find a replacement. I still work on the newsletter, the CSCS web page, and other efforts as time permits. I was always impressed by the energy and enthusiasm that the Central Services Classified Senate volunteers brought to the formation of our group. I believe it has represented us well and provides a platform to be included in shared governance in the district as well as a direct conduit for information. I strongly encourage all of you to consider becoming an active part of this group. Your fresh ideas and enthusiasm can ensure that CSCS remains an active and vital part of the operation of the district.

Day in the life of a Foothill-De Anza District Carpenter

The day begins with a nice warm cup of coffee to get the day going. It all starts at 6:00 AM so I can do as much work as I can without interrupting the students. I turn on my CPU and check the work orders for the day, then organize and prioritize my work for the week.

I schedule my day around broken doors and replacing hinges, removing and replacing white boards, building and installing custom shelves, patching holes in roofs, walls, and doors, along with building and rebuilding benches across the campuses, and setting up ramps for the stage for graduation, etc.

In addition, I have worked on several special projects for which I have been responsible for turning single large rooms into a multiple room classrooms and vice versa. I have installed T-bar Ceilings, put up drywall, and performed other tenant improvement work I also have installed interior vision windows and interior doors so you can access one room to the next without going outside. I have helped out with emergency situations such as broken windows, fallen trees, and damaged



pedestrian bridges. I helped keep the students safe and able to continue on with their studies.

There are two full-time District Carpenters, Elmano Salazares for De Anza College, and myself for Foothill College. We both share similar duties and responsibilities for both of the campuses. We help each other complete major building projects and critical situations. When in need, we help other trades complete their projects in a timely manner to keep the school in tip top shape. No job is too small, I treat them all the same. Our day ends usually at 2:30PM unless a critical situation arises.
